TREASURER'S REPORT FOR THE BSAP UK REGIMENTAL ASSOCIATION

For the year ended 31 December 2022 the BSAP Association made a loss of £4,718. In reality the actual loss was £2,660 as £2,058 was transferred to the Trust as 50% of the profit made by the Association in the year ended 31 December 2021.

As life started getting back to normal after Covid-19, more gatherings/meetings were in person, therefore expenses for venues have returned. The Association decided to subsidise one gathering per area to help with costs and the Scottish, West Midlands and Irish gatherings benefitted. There was also a donation of £1,000 that was made to the Zimbabwe Pensioners Support Fund UK.

Please note that subscriptions is over stated in 2022 by £1,015 which actually relates to 2021 year.
