ASSOCIATE MEMBERSHIP may be granted, as a privilege to such persons as the Committee deem desirable provided that such person, in the opinion of the Committee, has or had a close relationship with the BSAP or Regimental Association.

Note that voting rights and benefits for Associate Members are limited.

Annual subscription rates are currently £20 per year for members. You may pay more if you wish.

Subscriptions are renewable every year on 01 January and are payable by:

- **Bank Standing Order** - as it is the responsibility of each member to ensure they renew their subscription each year, **payment via Bank Standing order is encouraged**, as reminders are not sent out.

Also note that any other monies paid to the Association or BSAP Trust for whatever reason, do not take the place of the annual subscription.

Your application will be considered by the Executive Committee of the UK Branch and you will be advised of the outcome. If your application is approved your membership will only commence on receipt of your annual subscription (see details above).

Processing & Privacy Notice

This notice is issued in terms of the EU General Data Protection Regulations (GDPR) 2018

1. The Data Controller is the Executive Committee of the BSAP Regimental Association United Kingdom Branch (BSAPRA UK), and all enquiries are via the Honorary Secretary, BSAPRA UK (Rowan Tree Cottage, Lochton, Coldstream TD12 4NH or hon.sec@bsapuk.org).
2. It is a legitimate activity that we collect personal information data about individuals who are members of the BSAPRA UK, their partners and/or next-of-kin, We obtain personal information from our direct contacts with you, membership application forms and trading records to properly administer the BSAPRA UK and regulate and organise its activities in terms of the BSAPRA UK Articles of Association.
3. Personal information such as your regimental number, name and photograph could appear from time to time in the BSAPRA UK Outpost magazines, Newsflashes, Websites, closed BSAPRA Facebook pages or other BSAPRA UK internal media and/or publications.
4. We have a legitimate interest in keeping and processing the data to maintain a database to provide information requested and operate and administer the BSAPRA UK and its activities.
5. The processing is undertaken within the executive committee and sub-committees and only used for the purposes of administering the BSAPRA UK and fulfilling the objectives and obligations under its Articles of Association.
6. You have the right to know the information we hold about you upon receipt of a written request via the Honorary Secretary. We may make further enquiries to confirm that any such request is from you. We reserve the right to make a charge of £10 to supply such information.
7. We encourage you to update your personal information promptly if it changes and we will correct any errors to which we are alerted.
8. You have the right to be removed from our data list(s), but removal will result in your membership of the BSAPRA UK being terminated because we will be unable to properly administer your membership account with the Branch.
9. We will remove your details on receipt of a written request via the Honorary Secretary and unless there is a legal requirement to keep that information, we will delete it from our records.
10. Except where you have asked for removal, **we will** keep data for as long as we have a relationship with you and no longer than 7 years thereafter unless there is a specific reason to retain it.
11. We will not share your data, except in terms of the BSAPRA Articles of Association or where there is a legal requirement for us to provide information, **we will** refer any enquiry asking for your personal information to you when it is requested.
12. We reserve the right to modify and/or remove sections of this notice at any time but will advise you accordingly.
